2011 PITCHING MACHINE PRACTICE SCHEDULE**

Listed on the back of this sheet is the rotation for the use of the pithing machine fields # 1 & # 2. Just substitute your number at the bottom scheduled. Remember you are being scheduled for the whole field and the pitching machine. Please remember to turn off the lights if you are the last team practicing. Do not assume someone else will turn them off. Also you are not limited to practicing on the below times and dates. All teams are welcomed at the park and if they can find some space or possibly an empty field they may practice. If another team comes along and is scheduled for the field you are on, please be courteous and leave willingly. WPRD realizes that this is not much practice time but with the dramatic increase in participation we are running out of space. Furthermore fields # 1 & 2 are available on a first come first serve for Wednesday, and Saturday if there is not a game rescheduled on them. Medart Park is not the only place your team can practice. If you wish to practice at the local elementary schools, middle school, Wakulla Educational Center, or Wakulla High School you must let WPRD know so we can inform the Wakulla County School System.

Furthermore fields # 1 & 2 are available on a first come first serve for Wednesday, and Saturday if there is not a game rescheduled on them. Medart Park is not the only place your team can practice.
